

Learning From Avitation

Healthcare systems have looked to aviation, a safety-critical industry, for inspiration. However, they have not fully achieved the same level of learning from errors. Some principles have been lost or misapplied.



From aviation, we can gather crucial insights in three areas:

- 1. Fostering a Just Culture: Creating an environment where staff feel safe to report errors.
- 2. Analyzing Errors: Identifying weaknesses in systems and practices.
- 3. Integrated Investigations: Examining the entire system when investigating incidents.



Just Culture

Establishing a just culture in healthcare is challenging due to ambiguity and varying acceptable risks. A culture of safety requires balancing rights and responsibilities within cultural norms and legal protections. Aviation has spent decades establishing a just safety culture with careful agreements on safety data collection, access, and use. Within airlines, staff are assured of safety data confidentiality and non-punitive use, except in recklessness or wrongdoing.

Healthcare Challenge

Recognizing and reporting errors in healthcare can be challenging, as many fear the consequences of doing so.

Aviation Lesson

Aviation has fostered a "just culture" where staff can report errors without fear of punishment. This culture is supported by independent safety unit leadership.



Analyzing Errors

Most healthcare systems struggle to conduct integrated investigations across multiple organizations.

Healthcare Challenge

Analyzing errors in healthcare can be complex, given the inherent ambiguity in near-miss events.

Aviation Lesson

Aviation uses advanced methods to analyze errors and focuses on determining an acceptable level of risk in various contexts, along with appropriate safety strategies.



Improvement Focus

Aviation emphasizes prompt investigation and action, with improvements integrated into practice. Healthcare can learn from this approach, moving toward a more active process of inquiry and improvement.

Many healthcare systems struggle to conduct integrated investigations across multiple organizations.


Aviation Lesson

Aviation excels in conducting systematic investigations that involve multiple stakeholders, fostering a culture of active reflection and collaboration. This results in prompt integration of improvements into practice.



Drawing on Parallels

Drawing parallels between healthcare and aviation, we find that integrating safety practices from aviation into healthcare could lead to significant improvements in patient and employee safety. The lessons include creating a "just culture" - similar to aviation, effective error analysis, and an integrated investigation approach.
